AGREEMENT OF PAYMENT OF FEES FORM

- acknowledge that this Agreement of payment form an integral part of the Application for Enrolment to the Rainbow Kids E.C.D.C. to which this Agreement is attached;
- acknowledge that if the Application for Enrolment, accompanied by a payment of R600-00 non-refundable registration fee is accepted by Rainbow Kids E.C.D.C. such acceptance irrevocably binds me to make payment to Rainbow Kids E.C.D.C. in accordance with this agreement;
- 2,5% discount given on school fees is applicable if there is a sibling at the centre.
- 2.5% discount given on school fees paid in full for the year, on or before the 1st of February;
- accept that fees are payable before on or before the 1st of each month and the school fees are still due even if it is school holidays. There is also no reduction of fees for children going away during term time or due to absenteeism.
- I understand that January fees are to be paid in full when the school re-opens in January;
- I agree to give one calendar month's written notice if and when I withdraw my child from the school; and that **no notices are accepted after October.**
- understand that parents are to pay via direct deposit at the bank or electronically and must use their child's name and surname as a reference including submitting proof of payment immediately. The banking details are:

- accept that should I fall more than one month behind with school fees and have not discussed the matter with the Principal, I may be asked to remove my child from the school;
- accept that on condition that payment of the fees is made as set out in the Agreement, no interest will be payable by me. However in the event of any default in the payment of fees by me, I undertake to pay penalties on the school fees at the rate of R100-00 per month;
- in the event of legal action being instituted by Rainbow Kids E.C.D.C. for the recovery of any monies payable in terms hereof, I hereby consent to the jurisdiction of the Magistrate's Court in Terms of Section 45 of Act 32 of 1994 as amended;
- agree that in the event of any legal action being instituted as above, I will pay the cost thereof on an attorney and own client scale, including collection commission (plus VAT) also all expenses and disbursements incurred by Rainbow Kids E.C.D.C. of whatsoever nature including tracing agents charges, pursuant to such action being instituted. I further agree that all payments made by me shall be allocated firstly to costs and interest and thereafter to the capital;
- accept that no act of relaxation, indulgence or grace on the part of Rainbow Kids E.C.D.C. shall in any way operate as or be deemed to be a waiver by the school of any of its rights;
